Collecting Evidence

- Literature review
- Focus groups
 - 1 for people with disabilities, 1 for caregivers/parents, 3 for municipalities (small, medium, large size)
- Survey of municipalities on draft guide

- National plan for knowledge transfer and dissemination of the guide in 2025
 - Collaborating with P/T rec group leads
 - Plan will be completed by the fall of 2024
